Suitable forms of personal identification for adult application

- Current signed passport
- Current UK photo card driving licence
- Current full UK driving licence (old version)
- Current EU driving licence
- Senior Citizens Bus Pass
- Benefit book or most recent original notification letter from the Benefits Agency confirming the right to benefits
- Most recent HM Revenue & Customs tax notification such as tax assessment, statement of account, notice of coding. (P45s & P60s are not acceptable)
- For members who are self-employed in the Construction Industry a tax exemption certificate with photo (Forms CIS5, CIS6 or CIS4)
- Blue disabled driver's pass
- Debit card and an original account statement, less than 3 months old

Suitable forms of personal identification for junior account application

- Passport in child's name
- Medical card
- Birth certificate
- Child benefit book or most recent original notification letter, containing the child's name

Suitable forms of confirmation of address

- Current UK photocard driving licence
- Current full UK driving licence (old version)
- Recent utility bill. Not more than 3 months old
- Certificate from a supplier of utilities issued within the last 3 months confirming the arrangements to pay for their services on pre-payment terms
- Recent statement from a UK bank or building society containing current address
- The most recent original mortgage statement from a recognised lender
- Local authority tax bill (valid for the current year)
- Local council or housing association rent card or tenancy agreement
- Benefit book or most recent original notification letter from the Benefits Agency confirming the right to benefits
- Solicitor's letter confirming a recent house purchase or land registry confirmation. (Additional address ID required to verify previous address)
- Most recent HM Revenue & Customs tax notification such as assessment, statement of account, notice of coding (P45's & P60's are not acceptable)

NOTES:

1. You are required to supply one proof of personal identification and one proof of name and address, the same document cannot be used to confirm both.
